APPROVAL OF CONSENT AGENDA

UNFINISHED BUSINESS

❖ Bill 22-06 - An ordinance of the City of Osage Beach, Missouri, adopting an amendment to the zoning map of the City of Osage Beach, Missouri by rezoning a parcel of land as described in Rezoning Case no. 417. Second Reading

Alderman O'Steen made a motion to approve the second reading of Bill 22-06. This motion was seconded by Alderman Ross. The following roll call was taken to approve the second and final reading of Bill 22.06 and to pass same into ordinance: "Ayes" Alderman Becker, Alderman Ross, Alderman Schuman, Alderman Marose, Alderman O'Steen and Alderman Rucker. Bill 22.06 was passed and approved as Ordinance 22.06.

❖ Bill 22-10- An ordinance of the City of Osage Beach, Missouri, authorizing the City Administrator to accept the Municipal Equipment Company, Inc. service agreement to perform 3-phase lift station assessment inspections for specific station locations as listed in said agreement, for an amount not to exceed \$168,960. Second Reading

Alderman Schuman made a motion to approve the second reading of Bill 22-10. This motion was seconded by Alderman Ross. The following roll call was taken to approve the second and final reading of Bill 22.10 and to pass same into ordinance: "Ayes" Alderman Becker, Alderman Ross, Alderman Schuman, Alderman Marose, Alderman O'Steen and Alderman Rucker. Bill 22.10 was passed and approved as Ordinance 22.10.

NEW BUSINESS

❖ Bill 22-11 - An ordinance of the City of Osage Beach, Missouri, amending the Osage Beach Code of Ordinances by creating a new Section 109.1 (d) within Section 500.020, eliminating the inspection fee for repair or replacement of water heaters and HVAC systems, rebating any fees previously paid therefore and requiring a report to the Board of Aldermen about the time spent on courtesy inspections for these systems within the year. First and Second Readings

Alderman Ross made a motion to approve the first reading of Bill 22-11. This motion was seconded by Alderman Becker. Motion passes with unanimous voice vote.

Alderman Schuman made a motion to approve the second reading of Bill 22-11. This motion was seconded by Alderman Becker. The following roll call was taken to approve the second and final reading of Bill 22.11 and to pass same into ordinance: "Ayes" Alderman Becker, Alderman Ross, Alderman Schuman, Alderman Marose, Alderman O'Steen and Alderman Rucker. Bill 22.11 was passed and approved as Ordinance 22.11.

Bill 22-12 - An ordinance of the City of Osage Beach, Missouri, authorizing the Mayor to sign a contract with Stockman Construction for the Autumn Lane Improvements Project for an amount not to exceed \$192,999.00. First Reading

Alderman Ross made a motion to approve the first reading of Bill 22-12. This motion was seconded by Alderman Becker. Motion passes with unanimous voice vote.

❖ Bill 22-13- An ordinance of the City of Osage Beach, Missouri amending Ordinance No. 21.78 Adopting the 2022 Annual Operating Budget, Transfer of Funds for Necessary Expenses for the Autumn Lane Improvement Project. *First Reading*

Alderman Rucker made a motion to approve the first reading of Bill 22-13. This motion was seconded by Alderman Marose. Motion passes with unanimous voice vote.
