The Board of Aldermen of the City of Osage Beach, Missouri, conducted a Regular Meeting on Thursday, March 7, 2024, at 5:30 PM. APPROVAL OF CONSENT AGENDA

Alderman Ross made a motion to approve the Consent Agenda as presented. This motion was seconded by Alderman Marose. Motion passes with voice vote. Via Zoom Alderman Rucker.

UNFINISHED BUSINESS

Bill 24-08 - An ordinance of the City of Osage Beach, Missouri, authorize the mayor to execute an agreement with the Federal Aviation Administration (FAA) Sublease No. 697DCM-24-L-00008 at Lee C. Fine Memorial Airport, Kaiser, Missouri. Second Reading

Bill 24-10 was passed and approved as Ordinance 24-10. Via Zoom Alderman Rucker

Bill 24-11 - An ordinance of the City of Osage Beach, Missouri, authorizing the Mayor to execute supplemental agreement #10 with LOR Engineering dba Cochran Engineering to design the Rockaway Lift Station Emergency Storage for an amount not to exceed \$66,000. Second Reading

Alderman Marose made a motion to approve the second reading as amended to Bill 24-11. This motion was seconded by Alderman Hoffman. A roll call was taken to approve the second and final reading of Bill 24-11 and to pass same into ordinance: "Ayes", Alderman Marose, Alderman Hoffman, Alderman O'Steen, Alderman Ross, and Alderman Schuman. Bill 24-11 was passed and approved as Ordinance 24-11. Via Zoom Alderman Rucker

Bill 24-09 - An ordinance of the City of Osage Beach, Missouri, amending Chapter 610 Peddlers and Solicitors, Section 610.010 Definitions, Section 610.030 Identification Card Required for Peddlers and Solicitors-available for Canvassers, Section 610.040 Fees, Section 610.050 Application for Identification Card, Section 610.060 Contents of Application, Section 610.070 Issuance of Identification Card, Section 610.090 Denial-Administrative Revocation, Section 610.100 Hearing on Appeal, Section 610.130 Revocation of Card, Section 610.160 Violation to be prosecuted as trespass, adding Section 610.170 Additional Requirements for Mobile Food Establishments purposes of the City Code for various purposes as set forth. *First Reading and Second Reading*

Alderman Ross made a motion to approve the first reading of Bill 24-09 with written amendment including distance. Alderman Ross then withdrew his motion. Via Zoom Alderman Rucker

Alderman Schuman made a motion to remove Section 610.170 A3 from Bill 24.09. This motion was seconded by Alderman O'Steen. A roll call vote was requested for this motion. "Ayes" Alderman Schuman, Alderman Rucker, Alderman O'Steen. "Nays" Alderman Hoffman, Alderman Ross, Alderman Marose. Mayor Harmison exercised his duties under 110.020 and voted negatively to allow for Section 610.170 A3 to remain in Bill 24-09. Via Zoom Alderman Rucker

Alderman Ross made a motion to include the verbiage to Section 610.170 3A... unless operating on the property of an existing Bar or Restaurant with the permission thereof. This motion was seconded by Alderman Hoffman. A roll call vote was requested. "Ayes" Alderman Hoffman, Alderman Ross, Alderman Marose, Alderman Schuman. "Nays" Alderman Rucker, Alderman O'Steen. Motion passes 4 ayes 2 nays. Via Zoom Alderman Rucker

Alderman Ross made a motion to table the second reading of Bill 24-09. This motion was seconded by Alderman O'Steen. This motion passes unanimously with voice vote. Via Zoom Alderman Rucker

Bill 24-14 - An ordinance of the City of Osage Beach, Missouri, Amending Ordinance No. 23.90 Adopting the 2024 Annual Operating Budget, Transfer of Funds for Recruitment Costs *First Reading*

Alderman Marose made a motion to approve the first reading of Bill 24-14. This motion was seconded by Alderman Ross. This motion passes unanimously with voice vote. Via Zoom Alderman Rucker
