NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF OSAGE BEACH, MISSOURI AS FOLLOWS:

Section 1. That the section entitled Osage Beach amendments as set forth below with new material set out in **RED** and deleted material struck as follows:

Section 710.070. Violations

- A. ~~Any person found in violation of this Chapter or any requirement of a permit issued hereunder may be served with a written notice stating the nature of the violation and providing a reasonable time limit for compliance. Any such notice given shall be in writing and served in person or by registered or certified mail. The notice shall be sent to the last address of the violator known to the inspector. Where the address is unknown, service may be made upon the owner of record of the property involved. If satisfactory action is not taken in the time allotted by the notice, this Section shall be implemented.~~
- B. Any person who ~~continues to~~ violates the discharge provisions or sewer permit requirements of this Chapter beyond the time limit provided for in this Section shall be guilty of an offense or may be subject to disconnection from the City's wastewater facilities and subject to a penalty as provided in Section 100.190 of this Code.

Section 2. Severability

The chapters, sections, paragraphs, sentences, clauses and phrases of this ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional or otherwise invalid by the valid judgment or degree of any Court of any competent jurisdiction, such unconstitutionality or invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this ordinance since the same would have been enacted by the Board of Aldermen without the incorporation in this ordinance of any such unconstitutional or invalid phrase, clause, sentence, paragraph or section.

Items shall be sold to the highest registered bidder;

~~2. *Sale by sealed bids.* Public notice shall be made of the sale which shall include a general description of the item(s) to be sold and placed in at least one (1) local newspaper of general circulation and on site at City Hall and electronically via the City's website no less than fifteen (15) calendar days prior to sale's end date and time. Sealed bids shall be delivered to and held by the office of the City Clerk who shall conduct the bid opening at said date and time established by the formal notice;~~

CITY-PROVIDED ELECTRONIC DEVICE PURCHASE PROGRAM POLICY

The City of Osage Beach provides laptops, computers, phones, and tablets to employees when their job duties or the business needs of the City require such devices. In accordance with an industry standard replacement schedule, these devices are replaced on a regular cycle every 4 to 6 years, depending on the type of device. Once replaced, the device is typically deemed surplus property and disposed of in accordance with Section 135.080 of the City's Municipal Code.

Under this policy, and at the discretion of the Information Technology Director, employees of the City of Osage Beach may be allowed to purchase their assigned device at the time of replacement. Employees will have one week following the replacement to confirm their intent to purchase and submit payment to the City via cash, check, or credit card. The Information Technology Department will determine the purchase price based on the device's average fair market value.

If the employee declines to purchase the device or does not respond within one week, the device may be offered to other employees who do not currently have an assigned device. Interested employees must opt into the program, and a lottery system will be used to select the next eligible buyer. If the selected employee declines, the opportunity will pass to the next name drawn. If no employees choose to purchase the device, it will be moved to the City's surplus inventory.

Devices sold to employees will be offered **as-is**, with **no implied warranty**. Additionally, City of Osage Beach IT staff will not provide support or troubleshooting for surplus devices. For devices with removable hard drives, the physical storage media will be removed prior to sale. For devices with integrated storage, the media will be wiped and all data specific to the City of Osage Beach will be removed.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF OSAGE BEACH, MISSOURI AS FOLLOWS:

Section 1. That the section entitled Osage Beach amendments as set forth below with new material set out in **RED** as follows:

ARTICLE VI BUSINESS RELATIONS

Section 100.250. City Approvals – Denial, Suspension, and Revocation.

- A. *Definitions.* For the purposes of this Section, the following terms shall have the following meanings:

APPLICANT or PERSON — An individual or a corporation, firm, partnership, joint venture, association, organization or entity of any kind, including any shareholder, owner, officer, partner, joint venturer or member of such entity or any other person holding an ownership interest in such entity.

CITY APPROVAL — Any license, permit, franchise, certificate, stamp, seal, or other approval of any kind issued or granted by the City.

RELATED PERSON OR ENTITY —

1. A firm, partnership, joint venture, association, organization or entity of any kind in which the applicant holds any stock, title or other ownership interest of at least twenty percent (20%);
2. A firm, partnership, joint venture, association, organization or entity of any kind which holds any stock, title or other ownership interest in the applicant of at least twenty percent (20%); or
3. An individual, firm, partnership, joint venture, association, organization or entity of any kind whose affairs the applicant has the legal or practical ability to direct, either directly or indirectly, whether by contractual agreement, majority ownership interest, any lessor ownership interest, familial relationship or in any other manner.

RELEVANT LAW —

1. Any statute or regulation of the United States, except that no denial, suspension, or revocation of any city approval shall be based upon violations of federal law caused solely by the sale, possession, and consumption of marijuana protected by Article XIV of the Missouri Constitution, provided that such activity complies with: all requirements of said article; all statutes, rules, and regulations issued pursuant thereto; and **Section 210.1800** of this Code;
2. Any statute, rule, regulation, notice, condition, term, or order of the State of Missouri or any department, division, or subdivision thereof;
3. Any ordinance, rule, regulation, notice, condition, term, or order of the City; or
4. Any ordinance, rule, regulation, notice, condition, term, or order of any other political subdivision with authority to enforce the same against the applicant.

- B. *Statement of Policy.* The City of Osage Beach welcomes all lawful business, industry, and commerce and encourages the responsible operation thereof. The procedures and penalties set forth in this Section are remedial in nature and shall be used to obtain compliance where possible. Denial, suspension, or revocation of a city approval is a harsh remedy to be used only after exhausting other reasonable methods, and then only as necessary to ensure compliance with relevant law and protect the City and its citizens.
- C. *Grounds for Action.* In enforcing or administering the ordinances of the City, any appointed official or his/her designee may deny, suspend, or revoke any city approval upon any of the following grounds in addition to any others as may be specified in this Code:
1. Failure to be or remain in good standing with the City and State of Missouri on all taxes and fees due thereto;
 2. Purposely or knowingly operating in violation of any relevant law;
 3. The conviction, plea of guilty, finding of guilty, or *Alford* plea to three (3) or more violations of any relevant law within one (1) calendar year or five (5) such convictions, findings, or pleas within three (3) calendar years, by any of the following alone or in the aggregate:
 - The applicant or any related person, regardless of the cause or character of such violation(s);
 - Employees, subcontractors, or agents of the applicant, for conduct which occurred while acting on behalf of the applicant or on the premises of the applicant;
 - Customers, guests, invitees, or other persons permitted or suffered to be on the premises of the applicant;
 4. Failing to abate any nuisance, public or private, after receiving a Notice to Abate as provided in **Section 215.030**.

Nothing in this Section shall be deemed to require any appointed official to investigate the qualifications of any applicant without cause, but an appointed official should act upon credible information that any of the above grounds exists.

- D. *Denial.* Any appointed official denying a city approval to an applicant shall do so by serving notice stating the reasons for the denial and giving the applicant ten (10) business days to appeal. If no appeal is received within such time, the city approval shall stand denied.
- E. *Revocation.* Any appointed official revoking a city approval from an applicant currently holding said approval shall do so by serving notice stating the reasons for the intended revocation and giving the applicant ten (10) business days to appeal. If no appeal is received within such time, the city approval shall stand revoked.
- F. *Suspension.* In actions based upon:
1. conviction(s);
 2. civil judgment(s);

3. other material facts not reasonably in dispute;
4. clear and convincing evidence of an ongoing danger to the health, safety, or welfare of the City or its citizens; or
5. clear and convincing evidence of an ongoing purposeful or knowing violation of relevant law;

an appointed official may suspend the applicant's city approval i) for a specified period of time commensurate with the seriousness of the facts presented, ii) until such time as the facts supporting such suspension are remedied, or iii) until a final determination on revocation of such city approval provided revocation is sought at the same time. Such suspension shall be effective not less than ten (10) business days following the service of notice thereof, unless such suspension is premised upon grounds 4 or 5 of this subpart, in which case such suspension may be made effective upon service of notice.

- G. *Appeal.* If an appeal is received within ten (10) business days of service, the City Administrator shall examine the reason for the proposed action and the appeal. In considering the appeal, the City Administrator may, but shall not be required to, set or extend deadlines, interview witnesses, hold hearings, request more information, and do any other thing necessary or convenient to making a reasoned decision. At any time after receiving the appeal, the City Administrator may affirm, reverse, or modify the action according to the facts presented, and shall serve a notice notifying the applicant of his/her decision, which shall be final.
- H. *Subsequent Applications.* In acting on any application or reapplication by an applicant whose prior city approval has been denied, suspended, or revoked, the City may consider past actions and any violations of relevant law by the applicant or a related person or entity in considering whether to issue the city approval requested by the applicant. Taking into account the nature and character of the city approval in question and the need for the City to rely on representations and/or future conduct by the applicant when acting pursuant to the city approval, the City may deny the application or reapplication if relevant considerations are reasonably recent and/or of such character or magnitude as to reasonably call into question the fitness of the applicant or the City's ability to rely on representations and/or future conduct by the applicant. If a city approval has been denied, suspended, or revoked, the applicant may not submit a new application for one (1) year from the date of the denial, suspension, or revocation unless the City Administrator finds that excusable neglect, substantial new facts, or a change in circumstances warrants reconsideration.
- I. *Liquor Licenses.* This section shall not apply to licenses issued under **Chapter 600** of this Code.

Organization of personnel

- Define purpose and desired outcomes
- Define the leader role
- Determine the number of personnel necessary to manage the work
- Determine the skills needed
- Identify resources and systems (equipment, software, etc.)
- Organize best to: plan, staff, direct, coordinate, report, budget and execute

Context

- Turnover in leadership over past few years
- City hired from outside and promoted from within to fill key leadership positions
- Similar to all growing communities, this organization is maturing and evolving
- “Foremen” performing in a capacity that requires them to be exempt personnel (directing personnel, evaluating personnel, managing vital programs, developing recommendations for budget, purchasing, etc.)
- The market and labor laws recognize these positions as exempt or salary positions
- There are good reasons to create a “crew lead” for each functional unit within each division of Public Works
- City hired a third party (Raftelis) to assess public works, including organization and staffing

Raftelis Study Recommendation 9: hire an experienced Public Works Director (done) that can further assess and determine appropriate staffing among other needs

- The three Foremen are not properly valued based on the nature of the work being executed
- There are also other things the Director and these positions should be responsible for that further make the case for appropriate value
- The market values these positions at a higher level
- The three foremen are embracing the empowerment and responsibility

Noteworthy

- Federal labor laws require these be exempt positions
- The market generally values them in this order, highest to lowest: water, sewer, streets
- Rule of thumb: personnel costs vs total expenses, annually, is 25-35%
 - Current: Streets 17%; Water 23%; Sewer 22%

Recommendations

- *Reclassify* the Foremen to Superintendents (Pay level 11)
 - Create and hire “crew lead” (pay level 10) positions in water (1), sewer (2) and streets (1)
- There will be an increase in personnel costs in 2025
 - Hiring the new Director earlier this year is a factor in the need to amend the budget for water and transportation
 - Sewer has had vacancies and has not filled the foreman position
 - Transportation: base increase is 11%; compared to total compensation for 2024 it is a small decrease not including the value of comp time; add 3% for 2026
 - Budget amendment to transfer \$10,000 within the approved the budget
 - Water: base increase is 30%; compared to total compensation for 2024 it is a 1.5% increase not including the value of comp time; add 3% for 2026
 - Budget amendment to transfer \$24,000 within the approved budget
 - Sewer: base increase is 24%; compared to total compensation for 2024 it is a 24% increase not including the value of comp time; add 3% for 2026
 - No net impact to the 2025 budget due to reasons mentioned above
- Percentages of total expenses in each fund will grow and be near the bottom to middle of the rule-of-thumb 25-35% of total expenses

CITY OF OSAGE BEACH HANGAR LEASE AGREEMENT

THIS HANGAR LEASE AGREEMENT (the “Lease”) states the terms and conditions that govern the contractual relationship between the City of Osage Beach, Missouri (“**City**”) and _____ (“**Tenant**”), on the following terms.

I. TERMS

1. Defined Terms.

- a. “*Airport*”: Grand Glaize Airport (K-15) Lee C. Fine Airport (KAIZ) located at 957 Airport Road, Osage Beach, MO 65065 1111 Lee C. Fine Road, Brumley, MO 65017;
- b. “*Date of Commencement*”: _____, 202__.
- c. “*Hangar*”: Hangar _____ at the Airport;
- d. “*Initial Rent*”: \$_____ per month;
- e. “*Initial Term*”: the period from the Date of Commencement through December 31, 202__;
- f. “*Relevant Law*”: Federal, State, or local laws or regulations, including but not limited to all FAA rules, regulations, and grant assurances, and any law, regulation, requirement, and/or directive issued by any federal, state, or local authority having jurisdiction over this Lease, Tenant, or City;
- g. “*Renewal Rent*”: the Rent for any Renewal Term;
- h. “*Renewal Term*”: an additional one-year Term beginning January 1 and ending December 31 of the relevant year.

- 2. **Use of Hangar.** City hereby demises and leases the Hangar to Tenant. The Hangar is to be used by Tenant for the purpose of the storage of aircraft only.

Fueling, maintenance requiring the use of petroleum products, or any commercial venture conducted out of the hangar is prohibited unless otherwise agreed to in a

separate signed writing. Make, model, registration number, and proof of ownership of said aircraft shall be furnished by Tenant to City. Any changes of aircraft shall also be reported to City. In Tenant's use and occupancy of the Hangar, Tenant shall act to keep the Hangar free from obstructions for the safe, convenient, and proper use thereof by all persons using the Airport.

Tenant shall not use the Hangar in violation of any Relevant Law. Tenant shall conform to all changes to this Lease made necessary by any Relevant Law. Tenant shall not exercise the rights granted by this Lease in such a way as to interfere with or adversely affect the use, operation, maintenance or development of the Airport.

3. **Term of Lease.** The Term of this Lease shall be the Initial Term. Provided Tenant is in full compliance with the terms of this Lease, Tenant may, at its option, renew this Lease for a Renewal Term. Such renewal shall be effective automatically unless Tenant gives City written notice of its intent not to renew no later than December 1 of the year preceding the Renewal Term.
4. **Rent.** The Rent due from Tenant for the Initial Term shall be the Initial Rent. The Rent shall be pre-paid in monthly installments beginning on the Commencement Date and a like sum on or before the 1st day of each month thereafter. Partial months shall be prorated *per diem*.

City may set Tenant's Renewal Rent prior to any Renewal Term by giving notice of the new rate to Tenant no later than November 1 of the preceding year. By entering into a Renewal Term, Tenant agrees to pay the Renewal Rent.

All payments by Tenant to City pursuant to any provision hereof shall be made payable to the order of City and delivered to City's address listed herein or at such other place as City may designate from time to time. City reserves the right to require electronic payment via ACH or similar process at its sole discretion.

Failure to pay any Rent when due shall result in a breach of this Lease. All past-due amounts under this Lease shall bear interest at the rate of 1.5% per month.

5. **Utilities.** Tenant shall only use such utilities as are provided by City and agrees to prevent wasteful and excessive use of utilities while in possession of the Hangar. Tenant shall also be responsible for and pay for all removal of trash from the Hangar.
6. **Alterations, Maintenance, and Repairs.**
 - a. Tenant has examined and knows the condition of the Hangar and acknowledges that no representations as to the condition and repair thereof, and no agreements

or promises to decorate, alter, repair or improve the Hangar have been made by City prior to or at the execution of this Lease.

- b. The interior of the Hangar shall be the responsibility of Tenant. City will be responsible for maintenance of and repairs to the roof and exterior walls of the Hangar. Tenant will be responsible for all other maintenance and repairs necessary during the Term of this Lease, and replacement of any fixtures located in or about the Hangar.
 - c. Tenant shall return the Hangar to City upon expiration of the Term hereof in the condition in which the same were in when delivered by City to Tenant, subject to normal wear and tear.
 - d. Tenant shall keep the Hangar and appurtenances thereto in a clean, sightly and healthy condition at Tenant's expense. If the Hangar shall not be kept in a clean, sightly and healthy condition by Tenant, City may enter the same without such entry constituting a termination of this Lease or an interference with the possession thereof, and restore the Hangar to its condition as of the Commencement Date, and Tenant agrees to pay to City, in addition to the Rent described herein, the expenses of City in thus replacing the Hangar in that condition. Tenant shall not cause or permit any waste, misuse, or neglect of any fixtures.
 - e. Tenant shall not bore, cut into, or otherwise weaken any wall, column, beam, or other part of the Hangar for any purpose whatsoever without the written consent of City, and in the event Tenant shall so bore, cut, or weaken any part of the Hangar City may at once enter and repair any damage done or replace any parts, and charge the cost of the same to Tenant, or City may, at its option, pursue any other remedy herein provided. Tenant agrees not to paint or otherwise alter the walls or structural members of the building.
 - f. City reserves the right to make other repairs, additions or alterations to the Hangar provided that such repairs, additions or alterations will be performed in such a manner to minimize any interference with Tenant.
- 7. Ownership of Improvements.** All betterments and improvements in or about the Hangar, made by either party (except Tenant's personal property, furniture and furnishings), including all heating, ventilating and air conditioning equipment, and all pipes, ducts, conduits, wiring, paneling and partitions, shall become the property of City and shall remain with the Hangar as a part thereof at the expiration or sooner termination of the Term of this Lease. Should Tenant repair or replace any such improvements, the repaired or replaced items shall nonetheless remain City's property. In no event shall Tenant

assign, lien, mortgage or create a security interest, which is superior to the interests of City in the Hangar.

8. **Entry.** Tenant hereby authorizes City, or its representative, to enter the Hangar without notice at any reasonable time for any reasonable purpose including but not limited to the following reasons:
- a. In the event of a fire or other emergency;
 - b. To search for and silence an activated Emergency Locator Transmitter, including but not limited to entering the hangared aircraft if Tenant or aircraft owner cannot be located immediately. In such instance, Tenant will later be notified by City;
 - c. To inspect, maintain, or repair the hangar;
 - d. To do anything required to comply with any Relevant Law.

City shall provide one key to the Hangar. The key, and any key copies, shall be returned to City upon termination of the Lease. No other locks will be permitted. Unauthorized locks will be removed.

9. **Safety.**

- a. Tenant shall not use in or about the Hangar any portable or other electrical equipment with a current amperage requirement in excess of eight (8) amps. In addition, Tenant is expressly prohibited from using any type of electrical engine pre-heating devices (except those permanently mounted on an engine) while Tenant is not in or about the Hangar.
- b. Tenant shall be responsible for providing and annually maintaining a fire extinguisher with a minimum of 10 pounds capacity with ABC rating.

10. **Insurance.** Tenant shall be responsible for obtaining any forms of insurance Tenant deems necessary which may include, but not be limited to, loss of rents coverage, business interruption coverage, and personal property coverage. Nothing contained in this section, or the balance of this Lease, shall be construed to broaden the liability of City beyond the provisions of R.S.Mo. §§ 537.600 or 537.610, nor to abolish or waive any defense at law which might otherwise be available to City or its officers and employees.

11. **Control, Maintenance, and Repair of Airport and Airspace.**

- a. Nothing herein shall be construed to grant an exclusive right within the meaning of Section 308 of the Federal Aviation Act of 1958, as amended.

- b. City reserves the right (but shall not be obligated to Tenant) to maintain and keep in repair the landing area of the Airport and all publicly owned facilities of the Airport, together with the right to direct and control all activities of Tenant in this regard.
 - c. City reserves the right to develop or improve the landing area and all publicly owned air navigation facilities of the Airport as it sees fit, and without interference or hindrance.
 - d. There is hereby reserved to City for the use and benefit of the public a free and unrestricted right of flight for the passage of aircraft in the airspace above the surface of the Airport, together with the right to cause in said airspace such noise as may be inherent in the operation of aircraft, now known or hereafter used for navigation of or flight in the air using said airspace or landing at, taking off from or operating on or about the Airport.
 - e. City reserves the right to take any action it considers necessary to protect the aerial approaches of the Airport against obstruction, together with the right to prevent Tenant from erecting or permitting to be erected, any structure or obstruction on the Airport which in the opinion of City would limit usefulness of the Airport or constitute a hazard to aircraft.
 - f. This Lease shall be subordinate to the provisions of any outstanding agreement between City, the State of Missouri, and/or the United States relative to the maintenance, operation or development of the Airport, and any further extension, replacement, or enlargement thereof.
 - g. During time of war or national emergency, City shall have the right to enter into an agreement with the United States for military use of part or all of the Airport. If any such agreement is executed, the provisions of this Lease shall be modified as necessary to accommodate such agreement.
12. **Assignment or Subletting by Tenant.** The Hangar shall not be sublet in whole or in part to any person other than Tenant, and Tenant shall not assign this Lease without City's written consent; nor permit by any act or default of Tenant, any transfer by operation of law of Tenant's interest created hereby.
13. **Indemnification by Tenant.** Tenant shall indemnify, save, and hold harmless City, its employees, and agents, against any and all claims, damages, liability and court awards including costs, expenses, and attorney fees incurred as a result of any act or omission by Tenant or its agents, guests, invitees, or assignees arising out of this Lease.

14. **No Indemnification by City.** Nothing in this Lease shall be construed to require City to indemnify Tenant. Such indemnification is illegal under Missouri law. See Mo. A.G. Opinion 138-87 (1987).
15. **Sunshine Law.** All material submitted to City will likely become public record and will be subject to the Missouri Sunshine Law, R.S.Mo. Chapter 610. Any material requested to be treated as proprietary or confidential must be clearly identified and easily separable from other materials. Tenant must include justification for the request. City's obligation to comply with the Sunshine Law supersedes any request by Tenant that material be treated as proprietary or confidential.
16. **Right to Terminate.** City reserves the right to terminate this Lease without cause by giving 30 days' written notice to Tenant. City may terminate this Lease upon written notice of any violation of this Lease if such violation is not cured within 7 days of such notice. City may immediately terminate this Lease for any material violation or any violation which creates a risk to the health, safety, or welfare of any person or property.
17. **Abandonment.** If, in the reasoned opinion of City, Tenant has abandoned the Hangar, City shall make reasonable attempts to contact Tenant at its last known address. If Tenant does not respond to such attempts after 10 days, City may, without notice, without judicial proceeding of any kind and without terminating this Lease, enter into and repossess the Hangar, and City may remove any property therein without being liable for any action or prosecution of any kind for such entry or the manner thereof, or loss of or damage to any property in or about the Hangar.
18. **Expiration or Other Termination.** At the expiration or other termination of this Lease, Tenant shall remove all goods and effects from the Hangar which are not the property of City and surrender the Hangar and all keys, locks and other fixtures connected therewith. Tenant authorizes City to store in the name and at the risk and expense of Tenant any personal property not so removed and to apply the net proceeds of such sale to the payment of any sum due hereunder, or to keep or destroy such property.
19. **Notices.** All formal notices or other documents required by this Lease shall be in writing and delivered personally or mailed by certified mail, postage prepaid, addressed to the parties. Notices to City shall be delivered to: City Clerk, 1000 City Parkway, Osage Beach, MO 65065. Notices to Tenant shall be delivered to Tenant's last known address, and it shall be Tenant's sole responsibility to provide such address to City. If Tenant fails to provide a mailing address, City may post notices on any entry to the Hangar. City may also serve notice to Tenant by personal delivery to Tenant or any of its owners, officers, or employees.
20. **Entire Agreement.** This Lease supersedes all agreements previously made between the parties relating to its subject matter. There are no other understandings or agreements

between them. Without limiting the foregoing, this Lease expressly supersedes any click-through, browse-wrap, or any other terms related to the subject matter of this Lease on any website or that otherwise may be presented to or required to be accepted by City or its employees and contractors while exercising rights under this Lease.

21. **Non-Waiver.** No delay or failure by either party to exercise any right under this Lease, and no partial or single exercise of that right, shall constitute a waiver of that or any other right unless otherwise expressly provided herein.
22. **No Adverse Inference.** This Lease shall not be construed more strongly against one party or the other. The parties to this Lease had equal access to, input with respect to, and influence over the provisions of this Lease. Accordingly, no rule of construction which requires that any allegedly ambiguous provision be interpreted more strongly against one party than the other shall be used in interpreting this Lease.
23. **Governing Law; Venue for Disputes.** This Lease was made in the State of Missouri and shall be interpreted under and governed by the laws of the State of Missouri. Any action arising out of this Lease or its subject matter, including both state and federal causes of action, shall be filed in the Circuit Court for Camden County, Missouri or the Associate Division thereof and the parties hereby consent and agree to the exclusive personal and subject-matter jurisdiction of that Court.
24. **WAIVER OF RIGHT TO JURY TRIAL.** THE PARTIES HEREBY KNOWINGLY, INTENTIONALLY, VOLUNTARILY AND IRREVOCABLY WAIVE ANY RIGHT TO A TRIAL BY JURY IN ANY ACTION ARISING OUT OF OR RELATING TO THIS LEASE OR ANY OTHER DOCUMENT OR TRANSACTION CONTEMPLATED HEREBY OR THEREBY, WHETHER BASED ON CONTRACT, TORT OR ANY OTHER THEORY.
25. **No Third-Party Beneficiaries.** Nothing in this Lease, express or implied, is intended to confer upon any other person any rights or remedies under or by reason of this Lease.
26. **Severability.** If any provision in this Lease shall be found to be void, the other provisions of this Lease shall survive and remain enforceable.
27. **Counterparts.** This Lease may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument. A facsimile or electronic (such as .PDF) copy of this Lease or a signature thereto shall have the same force and effect as an original.
28. **Binding Effect.** This Lease, subject to the above conditions of assignment, shall be binding upon and inure to the benefit of all parties and their respective legal representatives, successors, heirs, and assigns.

THIS AGREEMENT CONTAINS A WAIVER OF THE PARTIES' RIGHTS TO TRIAL BY JURY. THE UNDERSIGNED HEREBY MUTUALLY RELINQUISH AND WAIVE THEIR RIGHT TO TRIAL BY JURY.
